DATA

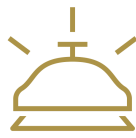

Your account

Among other things, we store the following in your account at www.butlerpoint.nl. Information on: your name, address, telephone number and e-mail address. We also keep data about previous orders so that you can easily find them, together with the invoice.

External suppliers and delivery services

We use external suppliers and delivery services to perform the services offered. We require our external suppliers to treat your data with the same care as we do and exclusively for purposes and under the conditions that we have agreed with them.

Newsletter and marketing

You can sign up for our newsletter. This way you stay informed of our offers, promotions and our news. If you no longer wish to receive a newsletter from us, you can easily unsubscribe via a link at the bottom of the newsletter. We may also use your contact details for marketing campaigns.

Improvement of our service

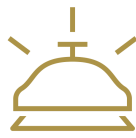
We are constantly improving our services. That is why we can use your data to ask you if you want to participate in a customer or market survey. We use the e-mail address you provided for this.

If you purchase services that cannot be paid immediately, we can call or email you to remind you of an invoice that has expired. We can also pass your details on to a collection agency and/or enforcement officer who collects unpaid invoices on our behalf.

STORAGE AND STORAGE TERM

We only keep your personal data for as long as and to the extent that we need it. We will in any case retain the information that we necessarily need during the term of our relationship or agreement. You can delete your account on our website, whereby your data will also be deleted. Invoice details about purchases are always kept for our administration.
